

Unofficial Meeting Minutes

The Regular Board of Education meeting was called to order by President Ryan Novess at 6:15pm.

Members present: Ryan Novess, Mike Austin, Brandon Woods, Corey Horky, Rebecca Harvey, Michael Tindall, Kody Naylor. Absent: none

Agenda was approved by Austin, supported by Naylor. Roll call vote: All yes (7-0)

Motion by Woods, supported by Austin to approve the Treasurer's report. Roll call vote: All yes (7-0)

COMMUNICATION

- A. Correspondence – Thank you note from Mr. Mark Ball
- B. Public Questions/Comments - Harvey made a motion to amend the Agenda adding the suspension of Board policies to Old Business - Crazy Ca\$h request, and publicly stating the scores on the evaluation for Superintendent Bezeau as well as approving the evaluation in Open Session after the Board returns from Closed Session; Austin supported the motion. Roll call vote: All yes (7-0)

OLD BUSINESS

- A. Extended COVID-19 Learning Plan - The Board approved the learning plan as presented. Motion by Austin, supported by Woods. Discussion: Harvey wondering if this would continue as is for the summer programming in lieu of many restrictions being lifted tomorrow; Dr. Bezeau stated this is a formality, but we will continue to monitor the WCHD guidelines. Roll call vote: All yes (7-0)
- B. Disposition of Real Property - Presentation of Purchase Agreement - Ackerson - The approved the agreement as presented. Motion by Austin, supported by Tindall. Roll call vote: All yes (7-0)
- C. Crazy Ca\$h Request - The Board approved the request that alcohol / alcohol consumption be allowed strictly in the Commons at the Jr/Sr High School and only for the night and time that Crazy Ca\$h is held (September 11, 2021 - 5:00pm-12:00am), with the understanding that event tickets will only be sold to attendees age 21 and over. Motion by Woods, supported by Naylor. Discussion: Tindall is in favor of the event, but not of the location. Harvey questioned who would be monitoring the age restriction; Dr. Bezeau stated it would be done at the door. Harvey is not in favor of the date due to historical reasons (9/11). Roll call vote: Yays - Novess, Austin, Woods, Horky, Harvey, and Naylor; Nays - Tindall. Motion carries 6-1.
Addition to Agenda - The Board agreed to suspend Board Policies 3122.01 Drug-free Workplace (professional staff) and 4122.01 Drug-free Workplace (support staff) only for the night and time Crazy Ca\$h is held (September 11, 2021 - 5:00pm-12am) with a motion from Austin, supported by Woods. Roll call vote: Yays - Novess, Austin, Woods, Horky, Harvey, and Naylor; Nays - Tindall. Motion carries 6-1.
- D. Administrative / Administrative Support Employment Contract Renewals
 - 1. Motion by Harvey, supported by Austin to renew contracts July 1, 2021 - June 30, 2022 for the following: Shannon Cajic, Deborah Heskett, Jennifer Jones, Michael Maisano, Laura Nea, William O'Brien, Lizabeth VanBogelen. Roll call vote: All yes (7-0)
 - 2. Dr. Bradley Bezeaus' contract was extended one-year through June 30, 2024 with a motion by Tindall, supported by Naylor. Roll call vote: All yes (7-0)
 - 3. Special Education Director, Julie Charney's contract was extended for one year through June 30, 2023. Motion by Harvey, supported by Tindall. Roll call vote: All yes (7-0)
 - 4. Motion was made by Austin, supported by Harvey to extend Jr/Sr High School Principal and Athletic Director Eric McCalla's contract through June 30, 2023. Roll call vote: Yays - Austin, Harvey, Tindall; Nays - Novess, Woods, Horky, Naylor. Motion does not carry (no extension granted) 3-4.

5. Klager Principal and MECC Director, Karin Villarreal’s contract was extended through June 30, 2023 with a motion by Naylor, supported by Austin. Roll call vote: All yes (7-0)

NEW BUSINESS

- A. Borrow in Anticipation of State Aid – Pursuant to the State School Aid Act of 1979, the Board authorizes the superintendent and designee to complete the Resolution Authorizing Issuance of Notes in Anticipation of State School Aid for borrowing an amount not to exceed \$1,300,000.00 in order to meet cash flow needs. Motion to approve by Austin, supported by Tindall. Roll call vote: All yes (7-0)
- B. Tentative Agreement Between Manchester Community Schools and MCS Educational Support Personnel was approved as presented. Motion by Naylor, supported by Austin. Roll call vote: All yes (7-0)
- C. MHSAA Membership Resolution – Board approved the 2021-2022 MHSAA Membership Resolution. Motion by Tindall, supported by Naylor. Discussion: Horky wanted to know the cost ; Eric McCalla stated there is no cost. Roll call vote: All yes (7-0)
- D. School Bond Loan Fund - The Board adopted the resolution that approaches the estimated amount to be borrowed from the School Loan Revolving fund for the 2021-2022 fiscal year and certifies the amount of qualified debt mileage to be levied as presented with support from Tindal, motion by Austin. Roll call vote: All yes (7-0)
- E. MASB Membership – Board approved the 2021-2022 Michigan Association of School Boards annual membership fee as presented. Motion by Tindall, supported by Austin. Discussion: Harvey motioned to add a workshop if we could get it at a discounted rate, supported by Austin. Roll call vote: All yes (7-0) for adding a workshop. Roll call vote: All yes (7-0) for approving the membership
- F. Bell System Upgrade at the Jr/Sr High, not to exceed \$28,400.00 was approved as presented. Motion by Austin, supported by Tindall. Discussion: Harvey wanted to know if we are getting options; Mike Maisano stated no, but we can add them. Horky questioned why we need this; Mike Maisano said the old system is not supported any longer.
- G. DECA Field Trip request was approved as presented with a motion from Harvey, supported by Austin. Discussion: Harvey would like the students to come present to the Board after they return. Roll call vote: All yes (7-0)
- H. Block Scheduling - Jr/Sr High School. Eric McCalla presented the benefits - able to take more electives, more time in core classes/labs, credit recovery, enrichment. Dr. Bezeau stated students would have to manage 4-5 classes instead of 7 classes.
