Official Meeting Minutes

The Regular Board of Education meeting was called to order by President Ryan Novess at 6:00pm.

Members present: Ryan Novess, Mike Austin, Brandon Woods, Corey Horky, Rebecca Harvey, and Michael Tindall. Absent: Kody Naylor

Motion by Woods to cancel this meeting until they are able to meet in-person. Not supported.

Agenda was approved by Harvey, supported by Tindall. Roll call vote: Roll call vote: 5 yays (Novess, Austin, Horky, Harvey, Tindall); 1 nay (Woods).

Motion by Woods supported by Harvey to approve the minutes of the Regular Meeting on August 16, 2021. Roll call vote: All yes (6-0)

Motion by Horky, supported by Austin to approve the Treasurer's report. Discussion: Woods would like receipts supplied on BMO to see exactly what is purchased; Bezeau - Business Manager is working on it. Roll call vote: All yes (6-0)

OLD BUSINESS

A. Approval of Board Policies

- 1. Revised Board Policies - 2210, 2412, 2414, 3362.01, 4162, 4362.01, 5610, 5611, 6107, 6114, 6325, 7400, 8210, 8400, 8462, 8600

Motion by Austin, supported by Harvey to accept the revised Board policies as presented.

Discussion: Woods on 5610 would like to see the Board to be the ones to be able to allow re-entry of a suspended/expelled student into school, not the Superintendent. Roll call vote to approve the Board policies: 3 yays (Austin, Harvey, Tindall); 3 nays (Novess, Horky, Woods).

Woods made a motion to table policy 5610, but approve all other policies; supported by Horky.

Discussion: Austin doesn't think the Board should be involved in the suspension/expulsion decision. Roll call vote: 3 yays (Novess, Horky, Woods); 3 nays (Austin, Harvey, Tindall). All policies are tabled until the October Board meeting.

- 2. Approval of New Board Policies - 5335, 8450.01, 8450.05

Motion by Harvey, supported by Tindall to accept the new Board policies as presented.

Discussion: Woods on 8450.01 does not like the language if there isn't a mandate (from State, Health Dept) on wearing masks that the Superintendent can mandate it. Horky - Superintendent needs to be supported; he is acting in the best interest of the District. Tindall - Board should not be micromanaging Superintendent. Roll call vote to approve the Board policies: 5 yays (Novess, Austin, Horky, Harvey, Tindall); 1 nay (Woods). New Board policies pass.

 Motion by Woods; supported by Austin to appoint Ryan Novess as the delegate. No other nominees. Roll call vote to close nominations; All yes (6-0). Tindall made the motion to elect Novess as the delegate, supported by Woods. Roll call vote: All yes (6-0).
 Motion by Austin; supported by Tindall to appoint Harvey as the alternate delegate.. Roll call vote: All yes (6-0). No other nominees. Roll call vote to close nominations: All yes (6-0). Woods made the motion to elect Harvey as the alternate delegate, supported by Tindall. Roll call vote: All yes (6-0).

- D. JUUL Litigation - Discussion
 Dr. Bezeau informed Board members of the litigation: other Michigan Districts have joined the lawsuit, no cost to MCS, if awarded that money would go towards monitors, counselors. Harvey asked if we already had come detectors; Bezeau - yes. Let bring back at the October meeting to vote on.

- F. Youth Sports - Discussion
 Lead by Novess: Would it be beneficial to have youth sports run through the schools? There was no soccer this fall. Woods - Huge proponent of school running youth sports. Harvey - Who would be responsible at the school to run it? How would that affect the school insurance? Woods - Maybe AD secretary could help; Harvey - AD Secretary is part-time. Bezeau - It would have to be beneficial and have financial security for the school to run. Maybe we grow our Community Ed. Woods - Maybe have a parent board. Austin - Maybe the school could help facilitate, but not take it all on. Will discuss more at a later date.
